WHEREAS, after speaking with Highway Superintendent, and upon his request, \$40,000.00 needs to be moved to insure the CHIPS projects are being tracked properly,

Motion carried to hire a third part-time employee, through the summer, with the Highway Dept.

(7) Planning Board: Helen Dunlap spoke of roadside parking concerns around the lake roads. (per the Police Dept., it is illegal to park alongside a road if your vehicle is not completely off the pavement...)

She also discussed persons renting "port-a-potties" for what is meant to be a short period of time, and them being left, for indefinite periods of time.

Planning Board is still moving forward with Town signage and a commerce directory.

(8) County Legislator: Dennis Fagan updated us on mortgage tax distribution and anticipated sales tax disbursements.

Motion by Desrochers, second by Allen at 8:02 pm to enter into an executive session to discuss possible litigations. Carried unanimously.

Motion by Bason, second by Grimmke to re-adjourn to the Open Meeting at 8:23 pm. Carried unanimously.

Motion by Allen, second by Perry to hire legal counsel pertaining to ownership, documentation, etc... for the Wayne Village Cemetery. Carried unanimously.
