RE: BUDGET ADJUSTMENT AND BUDGET MODIFICATON NEEDS TO BE DONE TO THE HIGHWAY FUND.

WHERE AS, the State has provided an unanticipated enhanced State assistance to local governments for the rehabilitation and reconstruction of local highways, known as PAVE NY. The Town of Tyrone has and apportionment of \$38,070.48, a budget adjustment needs to be done to receive this apportionment.

WHERE AS, line item budget modifications needs to be done to the Highway Fund to keep line items from being overspent.

At this time, Kelly Houck, Dundee Central School Superintendent, spoke with us about voting that will be held on Nov. 10, 2016 from 12:00 pm to 8:00 pm at the Public Meeting Room in regards to several propositions and a referendum.

She explained that proposal #1 is to upgrade the bus garage, school roof, classrooms, etc... #2 is to upgrade the tennis courts so that they may also hold ice in the winter for skating, #3 is for track & field lighting (which is partly being funded by a donation).

New Business:

(1) Supervisor: Donald Desrochers announced that the tentative 2017 budget is complete and filed and would like to schedule the first Budget Workshop on Oct. 20th at 10:00 am in the Town Hall. All agreed to that date and time.

Donald also stated that Union Negotiations are slated for Oct. 18th around noontime or shortly thereafter. All agreed to that date and time.

Donald also advised us that the Town has received a Notice of Claim in regards to a motor vehicle accident which occurred on July 9, 2016 on West Lake Rd. This information has been forwarded on to the Town's insurance company. Town Attorney was also served a copy of claim.

He also announced that we have received the Town's Financial Stress Score from the State.

We are currently at 0.0%, which is significantly down from where we were several years ago.

Councilperson Grimmke penned a letter, to be forwarded to our Highway Superintendent, addressing several recommendations for speed limit changes, additional signage, and a possible flashing light at one intersection.

All Board Members signed this letter and Highway Superintendent will cover those which are for Town roads, other suggestions must be sent to the County and then the County will send this on to the State for review and study.

- (2) Town Clerk: Deborah Tyler read aloud her monthly report.
- (3) Justice Clerk: Bobbi Sparling furnished the Board with a copy of her monthly report.
- (4) Fire Department: Nate Tormey furnished the Board with a copy of their monthly report.

He announced that the September Gun Raffle went well with approximately 715 meals sold.

- (5) Code Enforcement: Not present.
- (6) Highway Superintendent: Not present.
- (7) Planning Board: Not present.
- (8) County Legislator: Dennis Fagan talked about the third-quarter sales tax which is typically the largest and said that both the IRL and Vintage Races went very well.

The County's 2017 pre-budget is available on their website.

Mark Rondinaro announced that there will be Schuyler County GOP Dinner on November 5, 2016 from 5:30 - 9:30 at Logan Ridge Estates.

(9) Lakes Association: Cartha Conklin said they had their last meeting for the season on Oct. 8th.

Dennis Fagan added that the lake treatments done on Lamoka this year were a success and talked of the proposed treatments for 2017.

- (10) Assessor, Vick Flynn, stated that she has sent out exemption letters. She also said that she is being told that STAR exemptions on new purchases will have to be submitted to the State. Existing home owner's are grandfathered and will continue to submit to the County.
