RE: PROVIDING LOAN TO CAPITAL FUND FOR TOWN HALL ADDITION START-UP

COST

WHEREAS, the Town Board has previously indicated its authorization to initiate the development of plans to construct an addition to the Town of Tyrone Hall, and

WHEREAS, the Town Supervisor in his capacity as the Chief Fiscal Officer of the Town, has authorized the establishment of a Capital Projects Fund in the Town's accounting system for the purpose of tracking the costs of this project, and

WHEREAS, there is a need for start-up money to finance engineering, site preparation and other preliminary costs of this construction project, and

NOW, THEREFORE, BE IT RESOLVED, that the Town of Tyrone Town Board hereby agrees to loan \$15,000.00 from the General Fund to the Capital Fund to provide liquidity for start-up costs associated with the Town Hall Construction Project.
