GENERAL FUND BUDGET: With total appropriations & revenues of \$297,249.00 with total revenues from Real Property Taxes of \$90,779.00.

HIGHWAY FUND BUDGET: With total appropriations & revenues of \$878,384.00 with total revenues from Real Property Taxes of \$542,049.00.

TYRONE FIRE PROTECTION DISTRICT: With total appropriations & revenues of \$153,000.00 with total revenues from Real Property Taxes of \$153,000.00.

WAYNE FIRE DISTRICT: With total appropriations & revenues of \$26,757.00 with total revenues from Real Property Taxes of \$26,757.00.

- (5) Code Enforcement: Not present but he furnished the Board with a copy of his monthly report.
- (6) Highway Superintendent; Matt Stiles read aloud his monthly report of the Highway Department.

He also stated that he is aware of the lighting issue on the bridge on Route 226 and he is addressing the situation.

- (7) Lakes Association: Cartha Conklin stated this is a quiet time of year for them.
