RE: INTERDUCING LOCAL LAW #01-21 OPT-OUT OF ADULT USE CANNABIS RETAIL DISPENSARIES AND ON-SITE CONSUMPTION SITES.

WHERE AS, the Town of Tyrone Board is considering the adoption of Local Law No. 01 of 2021, pursuant to New York State Constitution Article IX and New York Municipal Home Rule Law 10, to add Chapter 158 to opt-out of allowing cannabis retail dispensaries and on-site consumption sites from being established and operated within the Town of Tyrone, as is authorized under NYS Cannabis Law Article 4 (hereinafter referred to as the proposed action): and

WHERE AS, the proposed (legislative) action is proposed pursuant to NYS Cannabis Law 131 which expressly authorizes the Town Board to adopt a Local Law to prohibit the establishment of cannabis retail dispensary licenses and/or on-site consumption licenses within the jurisdiction of the Town and is subject to a permissive referendum, the procedure of which is governed by Municipal Home Rule Law 24,

WHERE AS, this resolution will be opened for public comment and a public meeting be held at the beginning of our regular town meeting to be held on December 14, 2021, and

NOW, THEREFORE, BE IT RESOLVED, that LOCAL LAW 1 OF THE YEAR 2021 KNOWN AS "OPT-OUT OF ADULT USE CANNABIS RETAIL DISPENSARIES AND ON-SITE CONSUMPTION SITES" be introduced to the public for public review.
