The Board members equally agreed that they will not alter or modify the Town's Solar Law simply to accommodate any one entity.

- (5) Code Enforcement Officer: Not present.
- (6) Highway Superintendent: Matt Stiles read aloud his monthly report. They are finishing up some seasonal projects and will soon be getting the vehicles ready for

He also reported that the new Kubota tractor is here and they have used several times and are pleased.

- (7) Planning Board: Rory Miller stated that he would like to see a Land Use Regulation put into place to simplify and clarify better the subdivision process as many applications they receive are already small parcels that owners want to subdivide into yet smaller parcels. This Land Use Regulation may be implemented within the Town's new Comprehensive Plan.
- (8) County Legislature: Not present.
- (9) Lakes Association: Cartha Conklin reported that October 15th will be their last meeting for the season at 10:00 am. They will start meeting again in April 2023.

Several members of the Lakes Assoc. are actively working to refurnish the new Town Hall with pictures, which were displayed before the remodel.
